### Interoffice Policy for Dealer/Lender Title Transactions

- Limit 3 title transactions at preferred office. Additional transactions may <u>not</u> be submitted to sub offices or main office.
- In excess of 3, paperwork must be dropped off before 3:00 p.m., with a signed check, and will be available for pick up on the following business day after 3:00 p.m. Limit of 10 transactions per check.
- Cut off time for ALL transactions is 4:00 p.m.
  - o Sub offices: 11:30 a.m. & 4:00 p.m.
- Only the most current forms will be accepted. Applications must be filled out completely with all pertinent information, along with all required documents in order for transactions to be completed. All incomplete paperwork will be returned to Dealer/Lender. A heavy volume of incomplete forms are being submitted.
   Some examples are listed below:
  - o Driver license number and State of Issuance
  - Empty weight and carrying capacity (when needed)
  - o Dealer / Previous Owner address
  - o Back of Title / MSO
  - o Mileage
  - o Lienholder information
